Entries will be (blind) juried by a panel of nationally recognized, professional plein air artists who are signature members in at least one major national art organization. PAAC keeps the names of the selection jurors anonymous. The juror of awards is not part of the selection jury. Both PAAC and Mary Williams Fine Arts will have online catalogs of all accepted works on their respective websites.

#### **EXHIBITION CALENDAR**

Mark these dates on your calendar. No exceptions will be made!

May 17, 2016 Deadline to submit entries at CaFÉτM (www.CallForEntry.org). Last day for entries is May 17<sup>th</sup> at midnight mountain time...**no exceptions**. Jurying begins the following morning.

May 26, 2016 Entrants' notifications will be e-mailed by CaFÉTM, and posted online thereafter.

**<u>Aug. 1-11, 2016.</u>** Arrival of hand delivered and shipped paintings. Exceptions, by pre-arrangement only, may arrive by the drop dead date Aug. 15

Hand-delivered work must arrive at the Gallery between 11am and 5pm. Check with gallery to make sure Mary is there.

A handling charge of \$25 per artist payable to Mary Williams Fine Arts will be required for all shipped entries to cover unpacking, storage of shipping boxes and repacking. It is recommended that artists use either Masterpak or Airfloat boxes for shipping.

# October 1-7, 2016

Unsold hand-delivered work to be picked up by artists **between 11am and 5pm** at the gallery, unless the artist has made other arrangements with the gallery. **PLEASE NOTE:** Gallery hours fluctuate so it is imperative that artists confirm hours prior to picking up work. (Any works not picked up by October 7 will be picked up by PAAC and held for a limited time only. Works not picked up from PAAC by October 7, 2016 will become the property of PAAC and will be disposed of at PAAC's discretion.)

**By October 10, 2016** Shipped works returned to artists.

By November 30, 2016 PAAC will pay the artists by the end of November for sold works.

### **ELIGIBILITY:**

Open to all current PAAC Members working in two dimensional media, *excluding* photography, mixed media, fiber and digital media. Membership information: www.pleinairartistscolorado.com

- Only original paintings *completed "en plein air"* in the last 2 years (2014, 2015and until the deadline in 2016) are eligible. Works that have been exhibited in previous PAAC shows are not eligible for entry. No studio paintings. Still life paintings will not be accepted unless clearly completed outdoors. This show defines a plein air painting as one started and completed entirely on location.
- Work done in class and/or under the guidance of an instructor is not eligible for entry.
- An artist who withdraws an entry after acceptance into the exhibition shall not be eligible to enter any PAAC exhibition for the two succeeding years.
- Maximum size is 575 square inches (including frame). *Note: this is equivalent to a 16x20 painting with a 3" frame*
- Digital images are assumed to be accurate representations of the entrant's original artworks. Artwork that differs markedly from the submitted image will be disqualified.
- Work **MUST** be available for sale. Any accepted work which is presold **MUST** be included in the show and gallery commission applies. Gallery/PAAC commission (40% Gallery, 10% PAAC, 50% artist)
- Paintings must be professionally framed in a fine art gallery-quality wood frame, (no lined frames, i.e. velvet, linen, etc. or metal frames) wired and ready to hang. No sawtooth hangers. Inappropriately framed pieces may not be hung, at the gallery's discretion. Gallery will allow artist to reframe the piece in an acceptable frame, at artist's expense, to remain in the show.

# **ENTRY REQUIREMENTS**

By entering into the show, all participating artists agree to the requirements herein.

There will be no exceptions to deadlines, specs or rules.

Entry submission is through CaFÉ<sup>TM</sup> only. See below for details.

The artist retains copyright to his/her image(s), however, by submitting to this show, artist agrees to PAAC's use of the images for publicity (including future PAAC event promotion) and archival purposes.

Artist is responsible for any shipping charges to and from the exhibition. Artist is responsible for insuring his/her own work during transit.

All fees, for example, Member dues, Entry fees Shipping fees, etc. are non-refundable, whether or not work is accepted and/or presented for exhibition. Entry fees and 2016 dues must be received prior to jurying or application will not be deemed complete.

Artist is solely responsible for completing application through the Café system. Only completed applications with fees will be considered.

**Sales:** Price specified on the entry will be the price listed throughout the show and is a retail price; no late changes. Sales will result in payment per the following based on the price specified on the entry: 40% Gallery, 10% PAAC and 50% Artist. Discounts on sales may be arranged between each artist and Mary Williams Fine Arts.

# **Shipping Information**

Accepted artists will be responsible for shipping and insurance both ways

All shipped work should include:

- 1. Prepaid shipping label. Art shipped without a prepaid return label will not be displayed until a return label is provided. Failure to provide a prepaid return label will result in a \$25 handling fee in addition to the bill for return shipping.
- 2. Identification tags attached to back of each accepted work (Include Artist Name, Title, Price, Medium).
- 3. For shipped works, neither PAAC nor the Gallery is responsible for breakage or replacement. Due to risk of damage when shipping glass, we suggest you use Plexiglas.\*

\*It is suggested that artists who ship glass should always cover it with a product called "glass skin" which is available from the Masterpak company... it holds the glass together in case of breakage in transit, is easily peeled off, and often is easy to re-use if people are careful with it. <a href="http://www.masterpak-usa.com/cat\_215\_glassskin.htm">http://www.masterpak-usa.com/cat\_215\_glassskin.htm</a>

### **Liability:**

All entries will be made at the risk of the entrant.

Artists are responsible for insuring their work during transit.

Mary Williams Fine Arts will provide Insurance on all works in the show while they are on the gallery premises for the wholesale value of the artwork.

Although PAAC and its members will use their best efforts to prevent such occurrences, neither PAAC, its members, WESTAF (CaFÉ<sup>TM</sup>), Mary Williams Fine Arts, nor any other organization connected with the show is responsible for loss or damage to artwork from any cause, including unpacking, hanging, or repacking.

# **ENTRY**

# **Entry fee: (Non-refundable)**

\$45 for up to three submissions; one additional image @ \$10.00 may be submitted; (Total of 4- \$55). Note: You may submit up to 4 (four) images but a maximum of 2 (two) may be selected to hang in the show.

A minimum of three submissions is required, so if entering only one or two images, fill in the remaining one or two entries with either blank JPGs sized to CaFE specifications, or use the same image and name it "Duplicate Entry." Entry fees paid on CaFÉ<sup>TM</sup> site.

### **INSTRUCTIONS**

How to Apply to PAAC Exhibition at CaFÉ<sup>TM</sup>. Please read all instructions carefully. Open for entries through May 17, 2016, midnight (mountain time). https://www.callforentry.org/faq.phtml

- 1. Register at www.CallForEntry.org
- 2. Go to My Portfolio and upload your images. *Your work is juried from the images you submit so be sure they are good quality.* Blurry, poor quality images are not acceptable. Tips for taking your own photographs available at www.callforentry.org/imaging\_tips.phtml. If in doubt, hire a professional photographer. Images should be cropped to only show the artwork, no frames. All images must be formatted to certain specifications in order to upload them successfully into the system. - 3. Select up to 4 images from your image portfolio.
- 4. Then go to APPLY TO CALLS, sort by Application Deadline and scroll down to 5/17/16. Or sort by Name, and scroll down to Plein Air Artists Colorado 20<sup>th</sup> National Juried Fine Art Exhibition and Sale.
- 5. Click on VIEW MORE INFO or APPLY TO THIS CALL

- 6. Submit application. (answer questions)
- 7. Check Out: Pay the \$45 (or \$55) entry fee online with a credit card or mail in a check payable to PAAC with "Show Entry" in the Memo line, to:

*Please note: Your images will NOT be available to jury until we receive your check*, so if you are paying by check, don't leave your entry until the last week. If entering at the last minute, you MUST pay with a credit card. The jury process starts one day after the deadline.

When application is submitted, artists immediately receive email notifications from CaFÉ $^{TM}$ . If you do not receive this email, you may not be entered. Check your spam folder first, and then check at CaFÉ $^{TM}$ . Artists will also receive email notifications from callforentry.org when they have been accepted or declined. Please check your spam filter.
